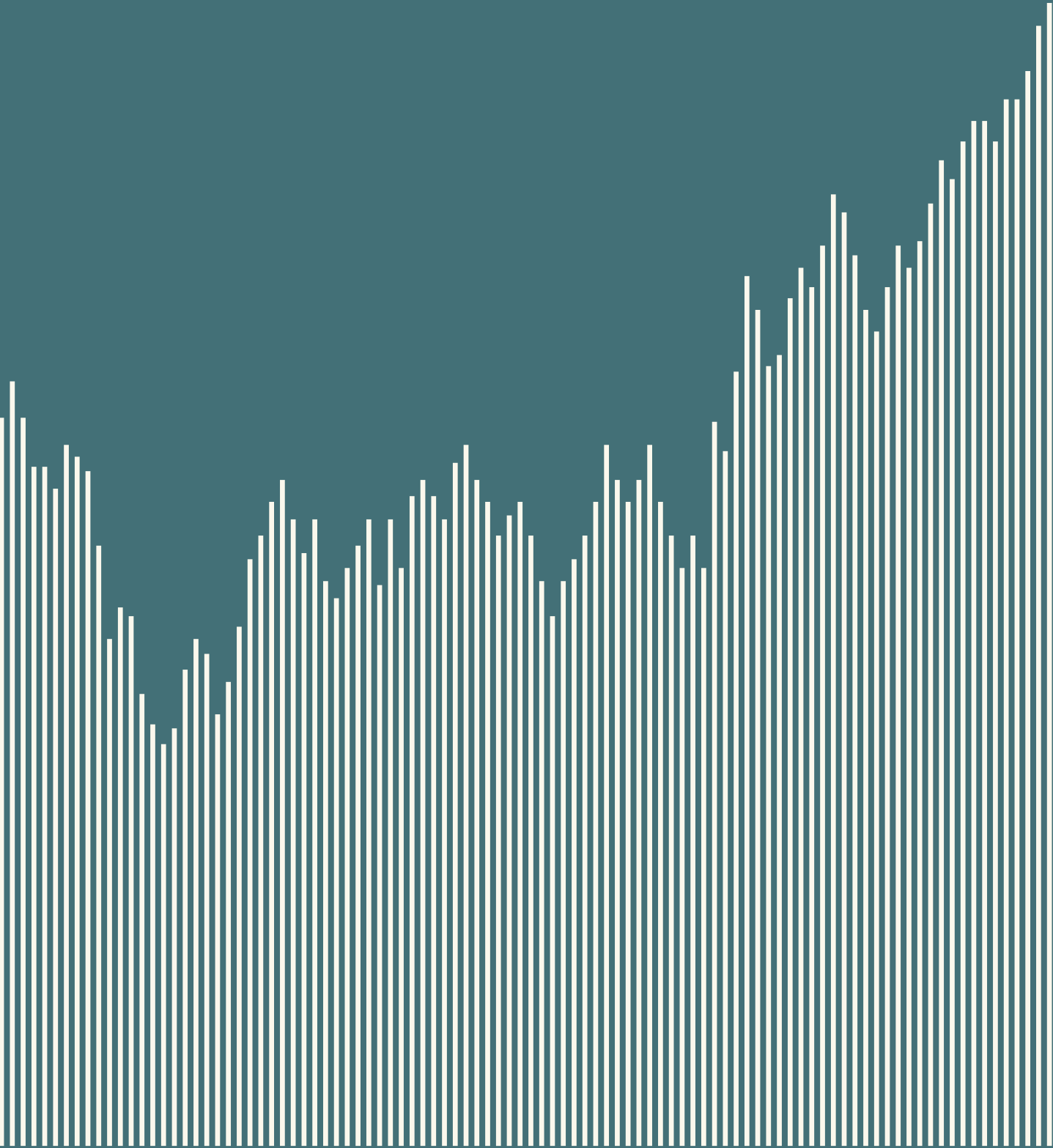

First Half of 2025 – Trump, Tariffs, and Rising Markets

If we were to summarize the first half of the year in two words, it would be: Donald Trump. Much of the market activity has revolved around what the U.S. President has said and done. The major theme of the year has been tariffs—or the potential for tariffs. Stock markets have largely moved in line with expectations around tariff levels. Markets, especially in the U.S., were weak until early April. This was a period when Trump repeatedly threatened to impose significant tariffs on trade partners. Investors were, understandably, concerned about how high tariffs might impact economic growth and corporate earnings. Trump did not appear particularly worried that the stock market was reacting negatively to the increased uncertainty.

It wasn't until the days following "Liberation Day" on April 2—when the bond market also pushed long-term U.S. interest rates higher—that Trump was forced to change course. From April 8 onward, markets have generally risen, driven by trade agreements, tariff postponements, and a generally softer tone from the White House. We are likely to see tariffs introduced at levels not seen in decades, but probably not as high as feared in early April.

This half-year has unfortunately also been marked by the conflict in the Middle East and the tragedy unfolding in Gaza. There is a risk of further escalation, which could lead to significantly higher oil prices. With a global economy showing signs of weakening and infla-

tion still slightly too high, rising oil prices are the last thing the world needs. If oil production or transportation is disrupted, we could see oil prices exceed \$100 per barrel. That would be bad news for the economy, most companies, and especially for consumers. The likelihood of an "oil shock" has somewhat decreased toward the end of the half-year, but the risk is far from gone.

Odin's Funds

It has been a half-year of mixed returns across our funds. Our Norwegian equity funds have risen by around 15% so far this year, in line with the performance of the Oslo Stock Exchange. The Stockholm Stock Exchange has also been relatively strong, with an increase of around 5%. ODIN Small Cap has risen by 8.9% so far this year, more than 3% ahead of its benchmark index. ODIN Micro Cap and ODIN Sverige have increased by 7.8% and 4.2%, respectively, both slightly behind their benchmarks. The Copenhagen Stock Exchange has been very weak this year, mainly due to Novo Nordisk, which fell by over 30% in the first half. Nevertheless, ODIN Norden has delivered a return of 2.3% so far this year, slightly behind the Nordic index.

Our global funds have performed weaker than our Norwegian and Nordic funds. The global index has declined by 2.3% this year, measured in Norwegian kroner. Our international funds have all posted negative returns between 1.8% and 7.5%. ODIN USA has been our

weakest fund this year, with a decline of 7.5%, around 2% behind its benchmark. The weak performance of the U.S. market and ODIN USA is mainly due to the Norwegian krone strengthening by over 10% against the U.S. dollar.

Positive Market Sentiment Persists

Despite geopolitical unrest, an unpredictable U.S. president, high interest rates, and still-elevated inflation, most economies remain remarkably resilient. Corporate earnings have generally been solid over the past quarters. Inflation has also come down significantly, prompting several central banks to begin lowering interest rates. An economy that avoids recession while interest rates decline is good news for the stock market.

Additionally, we believe Trump's agenda going forward may have the potential to be more market-friendly. Congress is in the process of approving significant tax cuts. There are also ongoing deregulation efforts, initially within the banking sector. We wouldn't be surprised if this contributes to pushing the stock market to new highs in the coming months.

A good first half of the year for Fixed Income funds

MARKET COMMENTS FROM
CIO FIXED INCOME, NILS HAST

The first half of the year has been characterised by a gradual stabilisation of inflation and the interest rate outlook. But there has not been a synchronized development between countries. At the beginning of the year, the market priced one cut in the US in the first half of 2025 and another cut in the autumn. The US Federal Reserve has taken a wait-and-see stance and has thus kept the policy rate unchanged during the first half of the year.

The Riksbank and Norges Bank have also delivered fewer cuts than the market expected at the beginning of the year. On the other hand, the ECB and the Bank of England have cut their key interest rates more than expected. This divergence can also be seen in macro data delivered so far this year. In the US and Norway, we have seen continued strong and resilient economies, while the figures in the euro zone and in Sweden have been significantly weaker. It should be added, however, that we have not yet seen the full effects of President Trump's tariff policy.

The market rebounded after tariff war shock

It seems that the financial markets have now begun to get used to Trump's style and many announcements. When the so-called Liberation Day came on April 2, the market was shocked by the high levels of the proposed tariffs. The market was unprepared, and we therefore saw strong reactions in both long-term interest rates and credit spreads. The

cross-over index illustrates this well. It measures the credit premium that the most liquid high yield issuers in euro pays for five-year loans. Throughout 2024, the index was relatively stable, in the range of 2.7–3.4 percentage points but rose to as much as 4.3 percentage points. In mid-May, however, the indices were back at a more normal level, around three percentage points, and ended the half-year at 2.8 percentage points.

In the Nordic high yield market, we saw the same movement in credit premiums. Credit premiums rose a lot in April, but unlike the European spreads, the Nordic spreads have not returned to the starting point yet. Part of the explanation for this is that we have seen a number of new companies enter the Nordic credit market during the spring, where they have typically had to pay a premium. If we look at the total return for the second quarter, which includes underlying interest rates, it is at par with the first quarter. The reason for this is that both 3-month STIBOR and NIBOR have fallen in line with cuts in policy rates.

Activity in the issue market has been high with EUR 430 billion in European investment grade and EUR 47 billion in European high yield, which is better than in the first half of last year. The Nordic high yield market has had a stellar first half with over SEK 150 billion in issues, which is well above the record from last year.

New high yield fund from Odin

At Odin, we launched the new fund ODIN Nordic High Yield on May 30th; a fund that invests in the Nordic high yield market and complements our product offering well as we have not previously had a pure high-yield fund. Given the challenge of at times poor liquidity in the Nordic high yield market, it was important for us to create a product that addresses this challenge and prioritizes the interests of long-term owners of the fund. We do this by having a notice period of a month for redemptions, but at the same time allow daily deposits into the fund. Monthly redemptions are still uncommon, but we see more and more players establishing similar products. This fund is only marketed in Norway.

A good first half of the year

It has been a very good first half of the year for our fixed income funds. All funds are up between 2.5 and 4.2 percent (in NOK), and all but one are ahead of their respective benchmark indices. The new high yield fund had a good first month in June and ended up 0.7 percent (in NOK). The inflows into our fixed income funds have also been good: net inflows so far this year amounted to NOK 2.5 billion.

Despite tariff wars and geopolitical turmoil, it has been a good first half of the year and we are looking forward to the second half. The European credit market looks stable with inflation in the euro zone and in Sweden appearing to



be on its way down towards the target of 2 per cent, and the expansionary fiscal policy expected in the wake of the rearmament of European defence. It also appears that the rate of defaults is decreasing and that downgrades by credit rating agencies have peaked. The solid public finances in the Nordic countries are also a positive, as the Nordic countries account for the largest part of our exposure.

However, there are several things that can affect this rather positive outlook. It is therefore comforting to enter the second half of the year with high effective yields in our funds – between 4.9 and 7.3 percent. The effective yield acts as a buffer against changes in interest rates and credit spreads. In concrete terms, this means that it will take

a lot for the funds not to deliver positive returns over the next 12 months.

We would like to thank our unitholders for their trust confidence in us and welcome the new investors in ODIN Nordic High Yield to Odin.

Odin stands firm in the work with responsible investments

HEAD OF SUSTAINABILITY, MARTE STORAKER

2025 has been a year where sustainability and ESG have faced growing resistance. The debate is particularly polarized in the U.S., but we also see it influencing discussions in Europe. Opposition and exchange of opinions are valuable contributions to the development of responsible investment practices. The debate does not weaken the relevance of sustainability – it reinforces the need for transparency about our assessments and how we operate.

That's why it's a priority for us to clearly communicate how we work with responsible asset management – both on our website and in dialogue with our clients. We have reviewed and improved the information on our site, published more in-depth content about our active ownership efforts, and plan to update fund information to clearly show what we do and how we work.

A new risk landscape demands clearer assessments

While ESG faces increased resistance, global conflict levels are rising. War, conflict, and growing rivalry between states have intensified social sustainability risks such as human rights violations, rule of law, and freedom of expression.

In 2025, we published more information on how we identify and assess compa-

nies operating in conflict zones. This has led to dialogue with companies at elevated risk of breaching our guidelines – and in one case, the divestment of our ownership stake.

To ensure our guidelines align with international norms and regulations, we have also updated the exclusion criteria for our funds. The funds no longer exclude all investments in weapons, but rather companies that produce controversial weapons and those that sell arms to states violating the rules of war and conflict. With this update, we acknowledge the need for strong defense while setting clear boundaries for weapons incompatible with international standards. Our ethical guidelines define which companies we should own. These are not financial assessments, but evaluations of our responsibility as owners.

ESG – a tool for understanding financial risk

ESG assessments are not ethical judgments. They are about understanding how environmental, social, and governance factors affect financial risk and return. We may invest in companies with high ESG risk – but we must assess whether that risk could impact the fund's performance.

Supported by sustainability regulations, ESG risk analysis is now an integrated part of all our investment evaluations.

The goal is to identify material risks related to environment, social issues, or governance that could negatively affect the fund. We continuously work to improve ESG assessments – including for companies we lend to. Broader and deeper analyses lead to better understanding of companies and risk factors, making us better asset managers.

Long-term investing requires insight and trust

We invest in companies we understand well, with business models and leadership we believe in. Sustainability is an integrated part of our assessment of a company's future earning potential and risk profile. We believe companies that responsibly manage climate, nature, human rights, and governance are better equipped to handle regulatory changes, market expectations, and physical climate risks.

We stand firm – and look ahead

Managing others' future savings is a great responsibility. In a year where sustainability is under pressure, it's more important than ever to uphold the principles of responsible asset management, transparency, and thorough analysis of the companies we choose to own.

Manager Comments:

ODIN Small Cap generated a return of 7.79 percent EUR during the first half of 2025. The benchmark index returned 5.59 percent EUR over the same period. The fund saw inflows of SEK 2,047,424,974 and outflows of SEK 2,250,475,592, resulting in a net outflow of SEK 203,050,619.

The first half of 2025 was characterized by a sideways-trending market, largely influenced by U.S. politics. Following Trump's announcement of global tariffs, global equity indices initially weakened but then began to recover, ending the half-year on a positive note. As the two reporting periods this year were relatively in line with expectations, the performance among the holdings was somewhat mixed in the first half of

2025. Over the long term, we continue to believe that our well-managed companies are better positioned to create long-term value than many other listed companies, some of which do not generate profits or carry significant balance sheet risks.

ODIN Small Cap has a significantly higher proportion of smaller companies compared to the benchmark index, which tend to show greater price fluctuations than larger companies. Market risk appetite increased at the beginning of the year, but interest in smaller companies declined following the tariff announcements. Since the market bottomed out, we have benefited as investors have turned to higher-quality small-cap companies, such as those held in ODIN Small Cap.

In the long run, however, it is the value creation within the companies that matters most—not the fluctuations in market risk appetite. We are confident that we have positioned the fund for what matters most: long-term returns.

At Odin, we focus on long-term investments in what we consider to be high-quality companies. There have been no changes in investment strategy, benchmark index, or the portfolio management team during the first half of the year. The fund's holdings have not been significantly exposed to risk factors other than those described in the fund's information document (KIID).

Manager comments:

ODIN Sustainable Corporate Bond delivered a positive return of 3.0 (1.7) per cent for the A NOK (SEK) class during the first half of the year. The fund is thus slightly behind its benchmark index, which returned 3.1 (2.0) per cent. As of the end of June, the fund had assets under management of SEK 2.41 billion. The fund saw inflows of SEK 291 891 476 and outflows of SEK 87 690 688 resulting in a net inflow of SEK 204 200 787.

The fund invests in companies that contribute to one or more of our seven selected sustainability themes. Investments may be in the form of sustainable bonds earmarked for ESG purposes, or conventional bonds issued by companies whose operations inherently support these themes. During the first half of the year, the fund invested in 14 green bonds, one conventional bond, one social bond, and one sustainability-linked bond (SLB). The fund allocated most

capital during the period to the sustainability themes Renewable Energy and Energy Efficiency, and Sustainable Transport and Infrastructure.

The three largest investments we have made so far this year have all been in green bonds, issued by Atrium Ljungberg, SBAB Bank, and Ferde AS, in that order. The first two contribute to the fund's sustainability theme of Renewable Energy and Energy Efficiency, primarily through the construction and upgrading of sustainable buildings in Sweden. Despite emissions from the building sector having fallen by 64% since 2005, the sector still accounts for around 22% of Sweden's greenhouse gas emissions and approximately 40% of the country's energy use. This demonstrates that even with significant progress, substantial measures are still required to meet both Sweden's and the EU's climate targets. The green bond issued by Ferde AS contributes to the

fund's sustainability theme of Sustainable Transport and Infrastructure by allocating funds to the development of Bybanen in Bergen, an electric public transport solution. A smaller portion of the bond will also be allocated to the expansion of pedestrian and cycle paths in Bergen. These projects help reduce greenhouse gas emissions from the transport sector and support Norway's zero-growth target, which aims for all growth in passenger transport in major cities to be met through public transport, cycling, and walking — not through increased car use.

At the end of June, ODIN Sustainable Corporate Bond comprised 91 different positions, with 73% in green bonds, 9% in conventional bonds, 6% in social bonds, 4% in sustainability-linked bonds, and the remainder held in cash.
